Adrian Stanley, The Charlesworth Group (USA)

An opportunity to see the cutting edge XML workflows offered by the Charlesworth Group and case studies demonstrated. You'll be shown how a styled Word document is converted to XML, paginated and ready to proof to authors all within 10 minutes and without any human intervention.

### Beyond the Experiment: The Scholarly Publishing Office and the Maturation of Library-Based Publishing

Maria S. Bonn, University of Michigan University Library
The goal of the University of Michigan's Scholarly Publishing Office is to
develop low-cost, scalable mechanisms for electronic publication and
distribution of journals, monographs and other digital scholarly content. This
presentation will focus on defining the roles of a traditional publisher and
how becoming a publisher transforms the nature of publishing.

### A Case Study of Online Publishing at CJC-Online: Experiences, Insights and Considerations for Adoption

Michael Felczak, Rowland Lorimer, Richard Smith, Simon Fraser University This paper will analyse the dynamics of technological development and innovation at the Canadian Journal of Communications (CJC), with a focus on issues of ownership and control, financial stability, publishing and technological expertise, editorial outlook and readership demand.

### Challenging ISI Thomson Scientific's Journal Citation Reports: Deconstructing "Objective", "Impact" and "Global"

Isagani Cruz. De La Salle University

What kind of literary theory can come out of a reading that has historically not taken into account more than half of the world's literature? Presents a case for a new way of evaluating journals.

#### **Charting OJS Diffusion**

Paula Smith, Athabasca University

Explores the experiences of a well-established open access e-journal, The International Review of Research in Open and Distance Learning and its adoption of OJS. Along with an overview of significant technological enhancements that OJS offers (i.e., reader tools, data harvesters, etc.), this paper will also critically examine 'human obstacles' encountered the adoption of OJS, using Rogers' Diffusion of Innovations as a theoretical framework.

### A content management strategy – implementing OJS and OCS at Swinburne University library.

Teula Morgan, Swinburne University of Technology
Discusses the Library's establishment of the Swinburne Online Journals
project to support open access journal publishing by the university, as part of
its commitment to support open access from two directions: open access
publishing and archiving in an open access repository.

#### **Cooperative Publishing Model & Libraries**

Raym Crow, Scholarly Publishing & Academic Resources Coalition (SPARC)

Raym Crow will speak on publishing cooperatives and the various forms they might take for nonprofit publishers, including societies, university presses, and universities.

### Creating an Open Scholarly Archive on Paulo Freire Joe Kincheloe, McGill University

#### **Creating Scholarly Communities and Fostering Innovation**

Gregg Gordon, Social Science Electronic Publishing

The Social Sciences Research Network (SSRN) has been successful in building an online community interested in accessing working papers. Explores SSRN's role as a catalyst for scholarly innovation through the creation, expansion and connection of different communities.

### A Critical Theory of Library Technology: Libraries & Electronic Publishing

Ajit Pyati, University of California

While libraries have transformed themselves into important technology access points, they are also in a position to articulate broader technology goals and development strategies. This paper examines the increasingly prominent role of libraries in technological development and advocacy (as in the case of electronic journals and institutional repositories) in light of a critical theoretical framework for library technology development.

## DiPP – An Open Access Initiative for Scholarly Communication Cordula Nötzelmann, Peter Reimer, Hochschulbibliothekszentrum NRW,

Discusses Digital Peer Publishing NRW (DiPP), now featuring 13 eJournals covering a broad spectrum of disciplines like history, virtual reality, social sciences, etc. DiPP provides the technical, legal and organisational framework and tools needed by an editorial office to get an electronic journal up and running, using mostly Open Source Software.

### eLanguage.net: Shifting the paradigm in linguistics from academic publishing to scholarly communication

\*Dieter Stein, Cornelius Puschmann, University of Duesseldorf
Scholarly associations can play a key role in fostering the adoption of Open
Access principles, because of the trust and prestige they enjoy among
researchers. The Linguistic Society of America (LSA), the world's largest
academic association in the field of linguistics, has launched eLanguage.net,
an e-journal aggregator and community platform for linguists from around the
globe. One innovative feature of eLanguage.net is the concept of co-journals
– fully independent e-publications, maintained by teams of specialized
researchers, which are centrally aggregated via ATOM and RSS feeds on the
website. All co-journals are managed by their editors via PKP's Open Journal
Systems (OJS) and the articles published in them are presented together with
content from three special-purpose blogs containing news relevant to the
discipline (book notices, institutional developments, opinion pieces).

## Embracing electronic scholarly publishing in Africa; the Kwame Nkrumah University of Science and Technology (KNUST) Library, Kumasi, Ghana as a case study.

Helena Asamoah-Hassan, Kwame Nkrumah University of Science and Technology (KNUST)

The participation of African libraries as publishers of scholarly electronic journals and other scholarly communications will be discussed; the PKP software, Open Journals System (OJS) is used by INASP to manage over 260 journals in Africa.

## Establishing an on-line editorial and publishing system: One year experience with Journal of Research in Medical Sciences Mahmoud Saghaei, Isfahan University of Medical Sciences

The story of a particular medical journal, the Journal of Research in Medical Sciences, in the intermediate transitional period from a purely paper-based to full on-line management system, is presented in a hope to share experiences

#### Extending OJS into Cultural Magazines: The OMMM Project

John Maxwell, Simon Fraser University

with other journals around the world.

Discusses the Online Magazine Management Models project, which seeks to explore the space on the periphery of journal publishing. Could the needs of cultural magazines be met through adapting OJS and/or using less formalized platforms such as wikis, blogs and other open-ended CMS tools?

#### **Google Scholar Digitization Initiatives**

Anurag Acharya, Google

Anuarage Acharya will describe the evolution in general of Google Scholar and a more specific initiative - journal backfile digitization.

#### The Impact of Open Journal Systems on a Mexican Journal

Alejandro Cabello-Pasini, University of Baja California

Ciencias Marinas is a bilingual (English and Spanish) journal publishing peerreviewed, scientific research on all aspects of marine sciences. This presentation will cover submissions, readership and tips on how to connect with potential readers.

### The Impact Of The Open Access Movement On Medical Based Scholarly Publishing In Nigeria.

Datonye Dennis Alasia, University of Port Harcourt Teaching Hospital Discusses the significant and positive impact of the Open Access movement on medical scholarly publishing in Nigeria, with the most influential projects being AJOL and AIM.

### Indian biomedical journals and Open Access: a case study at Indian Medlars Centre (IMC), New Delhi, India

Naina Pandita, Sukhdev Singh, Govt. of India, National Informatics Centre Describes the free access services of the Indian Medlars Centre, highlighting the transition of these service to open access and issues for adopting OJS. IMC offers medical professionals free access to peer reviewed Indian

biomedical journals through its databases, IndMED, a bibliographic database of over 70 peer reviewed journals and its full-text version, medIND.

#### Interoperable epublishing software components

Robert Forkel, Max Planck Digital Library (in the Max Planck Society)
A call to the epublishing developers' community to tackle the issue of interoperability. Describes a component based architecture for interoperability and presents the case for interoperability to overcome obstacles when trying to apply publishing models and software to new fields of science, based on our experience with Living Reviews.

#### Journal Publishing in China - Inside and Outside View

Adrian Stanley, The Charlesworth Group (USA)

An internal and external look at what's happening in the Chinese publishing world, from assistance with authors and submissions, to developments in online usage and publisher brand recognition. The presentation will show a number of different ways publishers, large and small, are collaborating in China; it will show some of the challenges that are being faced and offer unique solutions and a better understanding of this emerging giant.

### Lessons learned from a decade of open access publishing: The Resilience Alliance's experience

Lessons learned from a decade of publishing Ecology and Society, including migrating to - and modifying - OJS and how the journal's growth and continued success is linked to the use of this modified version of OJS's online peer review and publication system.

The author, the editor and publisher of the open access journal Behavior and Social Issues, will address his experience with taking the journal to open access in partnership with a major University Library.

Librarians as campus OA leaders: the University of Alberta experience *Pam Ryan, Denise Koufogiannakis, University of Alberta Libraries*Highlights the work of the University of Alberta Libraries (UAL), which has taken a campus leadership role in advocating and developing services in support of Open Access (OA) publishing. UAL is committed to the principles of OA and as such, we include OA products in our collections and support members of the university community who want to publish in OA formats.

School Library, based on OJS, designed to provide supervision and guidance
to journals from the start, with a goal for every journal to become selfsufficient in all non-technical aspects of journal management.

#### **Living Reviews - Open Access Online Publications**

Christina Weyher, Max Planck Digital Library (in the Max Planck Society) In this talk we shall present Living Reviews, open access online journals featuring an innovative editorial concept for the publication of high-quality scientific content. Living Reviews journals publish solicited, peer-refereed review articles that give an overview on the state of research in their specific fields. The articles offer annotated insights into the key literature and describe available online sources. Published reviews are regularly updated by their authors to incorporate new developments in the field—which is the significance of the word 'living' in the journal titles.

### Moving beyond the print versus electronic binary in scholarly publishing

Shana Kimball, University of Michigan University Library
Discusses dual format publication (print and electronic) as a sound,
economical and relatively low-effort way to increase the value, use and
visibility of scholarly journals and finding new ways for small campus
publications to distribute their back issues.

A Multi-dimensional Approach to the Study of Online Annotation Rick Kopak, Chia-Ning Chiang, University of British Columbia Presents a field study to collect data on patterns of highlighting, annotating, linking and link-typing behavior.

The National Library of Australia: open access to Open Publish Slobodanka (Bobby) Graham, The National Library of Australia
The National Library of Australia has made a decision to include Open Publish journals in the Library's collections, based on a successful collaboration between the Library and the Association for the Study of Australian Literature to migrate their peer-reviewed journal, JASAL, to an online format using OJS.

## Needed--An OJS Plugin for Facilitating Journal-Based Continuing Education Activities: Specs To Guide Software Developers

Glenn M. Hymel, Loyola University, \*Marcus A. Banks, New York University School of Medicine

Discusses an identified need for an OJS plugin to focus on continuing education (CE) activities, covering the conceptual model, technical requirements and broader applications of a combined journal / CE approach.

### New Models of Peer-Review: Implications for the Different Roles Journals Play in Scholarly Communities

David Solomon, Michigan State University

Medical Education Online, an open access journal covering all aspects of educating physicians and other health professionals for 11 years, is in the process of implementing a hybrid open review system, combining an open "preprint" section, screened by an editor, for reader comments, with conventional peer review. Results from the piloting of this hybrid open review process will be presented in light of a general theoretical discussion on open peer-review.

### New publishing models for scholarly communication and the Brazilian open access policy

Sely M. S. Costa, Universidade de Brasília, Hélio Kuramoto, Instituto Brasileiro de Informação em Ciência e Tecnologia

This talk focuses on the adoption of a national information policy concerned with the open access movement and implemented by the Brazilian Institute of Information on Science and Technology (Ibict), including the creation of over 150 journals with OJS, about 6 conferences with OCS and the development of institutional and discipline repositories.

### Newfound Press: Digital Imprint of The University of Tennessee Libraries

Linda Phillips, University of Tennessee

The University of Tennessee Libraries' Newfound Press began in 2004 to develop a framework for making peer reviewed scholarly and specialized works available worldwide, advancing the community of learning by experimenting with effective and open systems of scholarly communication. Building on local digitization investments, our vision is to consider works in all disciplines, encompassing scientific research, humanistic scholarship and artistic creation.

### Open access publishing and the repository – a strategy for sustainability

Sten Christensen, \*Ross Coleman, University of Sydney
Description and assessment of two projects focusing on OJS and OCS and
their integration into standard open repository services and Sydney
eScholarship, a library service explicitly 'supporting and developing emerging
or alternate forms of scholarly communication'.

### Open Access Web-Only Peer-Reviewed Journal for Radiology Case Reports: Development and Implementation

Felix Chew, \*Michael Richardson, \*Kira Lichtenfeld, \*Annemarie Relyea-Chew, University of Washington

Prior to the development of the open access Radiology Case Reports, conventional peer-reviewed journals in the field were increasingly unable to process case reports. The journal's objective was to create an economically viable peer-reviewed journal that filled this need. In its first year, Radiology Case Reports has not only survived but is actually thriving. This presentation will cover the rationale and objectives, development of the journal, results and future goals - including a goal to capture at least 50% of the market for radiology case reports.

### OJS goes mobile – An investigation of how to adapt OJS to meet the needs of mobile users

Shubhash Wasti, Lawrence Poon, Athabasca University
As OJS gains popularity, there will inevitably be a larger proportion of users accessing it from mobile devices such as PDAs and smart phones. This paper attempts to explore some of the issues surrounding the use of OJS system by mobiles users and possible steps OJS developers and plugin designers can take to make the system accessible to a wider base of mobile users.

#### OJS in an Afternoon (preconference)

John Willinsky, Kevin Stranack, Jon Whipple and other members of the PKP Team

This session will provide an overview of the OJS software for new users, including the editorial process, configuration options and customization tips. *Note:* There are two of these sessions scheduled concurrently. ### OJS in Brazil: A report on Ibict's implementation and technology transfer of PKP's OJS

Ramón Fonseca, Instituto Brasileiro de Informação em Ciência e Tecnologia (Ibict)

Describes the technical cooperation between PKP and Ibict with a user base of over 130 scientific journals and counting - the translation experience, an overview of the status of scientific publishing in Brazil, the technical issues faced working with past and current OJS versions, the technology transfer framework developed and issues encountered, as well as a forecast of what the future may hold for the software in Brazil.

#### OJS-MP3 Article Usage: A pilot study

Kathy Killoh, Paula Smith, Shubhash Wasti, Athabasca University With the explosion of MP3 players on the marketplace, mobile technologies are now in place that enables readers to access research and scholarly papers anywhere, anytime. This presentation reports on the results of a pilot study designed to introduce mobile technologies via Athabasca University's largest e-journal, The International Review of Research in Open and Distance Learning (IRRODL). As of June 2006, readers have the option of downloading IRRODL journal articles in MP3 format.

### Open Medicine: New Standards of Access and Independence Anita Palepu, University of British Columbia

Presents the experience of founding a new independent open access medical journal in the wake of a controversial instance of editorial interference and suspension of academic freedom that had resulted in the firing of the Canadian Medical Association Journals editors, followed by the resigning of the remaining editors and board.

#### Open Source Software in Education in Africa

Megan Watson, University of the Western Cape

One project to be presented is the African Virtual Open Initiatives and Resources collaboration project (AVOIR), which aims to overcome challenges to support African universities' e-learning initiatives by building capacity through the use and development of open source software and the creation of an open source community.

### Opening up scholarly information at the University of Illinois at Chicago

Nancy John, University of Illinois at Chicago, Edward Valauskas, First Monday, Mark Mattaini, Behavior and Social Issues, Mary Case, University of Illinois at Chicago

The key role played by the Library and the importance of a supportive, collaborative partnership with the campus computing center, in creating an infrastructure for publishing journals, such as First Monday and Behavior and Social Issues and managing conferences, using OJS and OCS.

The Utrecht University Library, involved in Open Access publishing since 2000 and a major player in academic publishing in the Netherlands, recently started the PARTNER Project which intends to create virtual knowledge centres (VKC's). These VKC's are researcher's workbenches with

collaboration tools, research project support and a knowledge base. With the idea of continuing to challenge conventional ways of working, we will investigate how to integrate OJS within these VKC's.

### A Professional Reading Environment, Modeled for a Renaissance English Knowledgebase

Ray Siemens, University of Victoria

Discusses the Renaissance English Knowledgebase (REKn) and the reading interface PReE from theoretical and pragmatic perspectives, focusing on thoughts and plans to integrate the products of groups such as the Public Knowledge Project (PKP), the Text Analysis Portal for Research (TAPOR), Synergies and the Canadian Research Knowledge Network (CRKN).

#### PKP and its Digital Humanities 'Readership'

Ray Siemens, Caroline Leitch, \*Analisa Blake, Karin Armstrong, University of Victoria; John Willinsky, Stanford/University of British Columbia
As the amount of scholarly research increases, publishers must address issues of how to increase user engagement. Understanding how users read and evaluate research materials, anticipating users' expectations of the reading tools and resources and addressing user concerns about the availability of online material will lead to improvements in the design and features of online publishing.

#### PKP and Leading Edge Developments

## The Stanford Encyclopedia of Philosophy's Publishing and Funding Model: What it Means for Open Access and the Library Community Edward Zalta, CSLI/Stanford University

From its inception in 1995, the Stanford Encyclopedia of Philosophy (SEP) was designed to be a dynamic reference work, in which each entry is maintained and kept up to date by an expert or group of experts in the field. In this talk, Ed describes the publishing model in detail and the innovative funding model to maintain open access to the SEP and raising funds to build a protected endowment fund for ongoing operational funds for SEP.

## The State of Acquisition, Organization and Use of Open Access Information Resources in Cameroon University Libraries: The Case of the University of Buea and University of Yaounde Libraries.

Charles Kiven Wirsiy, University of Buea, Cameroon
Discusses the acquisition, organization and use of Open Access Information
Resources in two of Cameroon's prominent Universities.

### Strengthening African Research Culture and Capacities Project Samuel Smith Esseh. University of British Columbia

In light of the over 250 African journals using PKP software to list their contents and abstracts in the African Journals Online program, this project seeks to conduct research on current African utilization of online technologies in scholarly publishing, and support a move to publishing full texts online by conducting Online Scholarly Publishing workshops in 6-8 African research libraries.

#### Synergies: The Canadian Information Network for Research

Erik Moore, University of New Brunswick, Synergies Steering Committee Synergies is a collaborative initiative of five Canadian universities: Simon Fraser University, University of New Brunswick, Université de Montréal (with the Consortium Erudit), University of Toronto and the University of Calgary. The primary objective of Synergies is the transformation of scholarly publishing from a print to digital environment. The publication of Canadian research results, particularly in the social sciences and humanities, continues primarily in print form at a time when comparable infrastructures are primarily on-line in other countries. Once the infrastructure is operational, production and dissemination services will be offered to all areas of scholarly research.
